I. PAEC Program Updates

PAEC Business Office - Ms. Debbie Tryon, Business Manager

Some members of the business office will again be out of the office with Infinite Visions software training. The business office is hard at work setting up employee data in our live data.

Ms. Tryon has begun gathering data and analyzing accounts in preparation of the 2019-20 PAEC budget and cost sheets.

The final IDEA Flow Though grant amendment has been completed and approved by ISBE. It was submitted due to staff changes in the business office of staff whose salary and benefits are in the grant.

The open position of Lunch Program/Special Education Records Secretary at PAEC has been posted on Applitrack and at the job bank at Illinois ASBO. We hope to begin interviews later in April and have a person in place in June or July.

Planning and communication is underway for summer school 2019 as it relates to business office documents.

Calculations and file preparations are being prepared to run retroactive payroll for PAEC employees before the end of the fiscal year once the collective bargaining contract has been signed by both parties.

PAEC Early Childhood Program/Pre K

March was busy in the Early Childhood Program. There were many meetings and evaluations that the EC evaluation team, therapists, and all teachers were very ready for Spring break.

The EC Autism class continues to be at full capacity if not higher than we prefer (10 children). There are 10 slots open in our Multi-Needs classroom (2 more than last year at this time) and 16 slots open between our three EC Cross Categorical classes (there were only 7 slots at this time last year). We anticipate 5 new students starting in April.

There were 5 children identified at the March 12th Preschool screenings for District 87 that will need a full case study evaluation.

We ended the month celebrating World Down Syndrome Day on March 21st by wearing crazy socks in the morning and afternoon sessions. Wearing crazy socks causes people to ask, "Why?" and it spurs a conversation about Down Syndrome. Why March 21st, the date was selected because it is the 21st day of the 3rd month of the year and it signifies the uniqueness of the triplication of the 21st chromosome, which causes Down Syndrome. We celebrated not only the uniqueness of Trisomy 21 but also how unique and special each one of our students and staff members are in the PAEC EC program.

PAEC Therapeutic Day Elementary School

The students in grades 3rd through 8th continue to prepare for the upcoming standardized state testing. All students in grades 3rd through 8th will participate in the Illinois Readiness Assessment in April. Students in grades 5th and 8th will also participate in the state Science Assessment test. The students have been preparing for the upcoming test.

The students continue to participate in various math and reading interventions, which are improving both FastBridge Reading and Math scores. The student's data continues to be analyzed to assess the gaps in learning that exist and interventions implemented. Classroom teachers and the Computer teacher are collaborating to work on projects as well as keyboarding skills.

The students' weekly participation in activity night and the CAAEL sports program continues to be a tremendous behavior incentive. We have experienced a noticeable increase in the number of students who are enjoying both activities. The students are also working on acquiring positive behavior tiger paws for being caught following expectations.

PAEC Academy at St. Domitilla

As of today, all of the annual reviews are completed. We still have a handful of EDC's but for the most part, meetings are completed for the year. Teacher and PA evaluations are also complete with the exception of the Teacher Summative meetings. Those meetings will take place in April. Report cards for 3rd quarter went out this week.

When we return from Spring Break, we will begin the IAR and DLM testing. Booklets are now arriving, we will give students a few days to settle back into the routine and then begin the testing process.

The Smiles Dentist program came this week and saw 21 of our students. Many of them were referred for treatment.

We are currently working on plans for graduation, which will take place on May 28th at St. Domitilla. We are also planning the eighth grade trip. This year our eighth graders have chosen to go to Dave and Busters.

PAEC Center

The month of March came in like a Lion! It seemed as though winter was endless. However, students have had some relief from cabin fever with recess being reinstated

DLM testing started this month. The computer lab is closed as students are testing throughout the day.

Women's History Month was observed this month. Evidence of this was displayed on bulletin boards and walls.

St. Patrick's Day was also celebrated! Staff and students were encouraged to wear green as Green River floats were distributed. The high school had a dance on the 20th to celebrate St. Patrick's Day

The 21st was Down Syndrome Day. Staff and students were encouraged to wear blue and yellow as well as crazy socks!

We also had a half-day in-service in which some groups participated in Google Read and Write Training, team meetings and classroom meetings were held. A picture exchange system was seen by the PAs to help support student's discourse with staff and fellow students.

PAEC Center Vocational Program/Transition Program

We currently have nine students with competitive jobs. A few students have gone on interviews and are awaiting to see if they receive a job offer.

Plans for an Open House/Transition Fair are underway. This is scheduled to be held on April 30th with presentations by staff and booths with resources for our students. Job coaches are starting to plan for next year by getting students to our Hines job sites to complete registration, get TB shots so they can be up and running when the new school year begins.

PAEC Therapeutic Day High School

To celebrate the winners of the Black History Month door content, a select group of students was able to view a diverse range of exhibitions geared toward contemporary culture. At the Chicago Cultural Center, student were able to experience live music and understand the genre of music and its impact on people during that time.

PSAT and SAT testing is scheduled to begin April 9th through April 12th. The week prior to testing, instructors will be encouraged to model lessons and guides from the practice PSAT and SAT to guide instructions. Since many of our seniors have already completed SAT testing in the previous year, they will be required to attend one school day. The non-attendance day will include community service hours for the seniors, which is required for graduation.

The month of March was a very difficult time for the staff and students of PAEC High School. We lost a student that was very dear to the hearts of our staff and students. Through the work of our Crisis Team, we were able to address the pressing needs of our entire building. The following supports included: additional social work support, therapeutic rooms to allow students to grieve and support one another through art and song, social work

supports for our teachers, the use of our police liaison for student and staff support, and a team of staff who went to the home to comfort the family.

Mr. Walker is scheduled to attend the Raising Our Voices: Bold Innovations That Empower Student conference to be held in Chicago April 3rd through 5th. The conference will focus on innovations that have yielded positive results when dismantling systems of inequity. NPEA (National Partnership for Education Access) has a focus on educational access and success through community partnerships with students, families, colleagues, and communities.

PAEC Therapeutic Day High School Vocational Program

We have a total of 20 students (some may be participating in more than one program) participating in our various work programs:

- Hilton Program AM 10 students (each participating 2 days)
- Fire House Subs AM 3 students (each participating 2 days)
- Leadership Program on PAEC Campus 11 students (5 are 4 days, 6 are 2 days)
- Hilton Program PM (with stipend) 2 students
- Custodial Program PM (with stipend) 3 students
- Lunch Program (with stipend) 2 students

Mr. Loving provides students seeking employment with job leads.

Ms. Pietrowski is working with new students to complete their transition planning questionnaire and interview.

Ms. Pietrowski meets with seniors working on post-secondary education goals.

On March 1st, 4 students went to Triton College for placement testing.

We currently have 28 students utilizing the Apex Credit Recovery program to advance their graduation date either as a part of their course schedule or on their own. So far this school year we have had 45 completed classes! The students are making great progress on reaching their goals.

PAEC Intervention Team

District 87

Jefferson Primary School

Two Behavior Coaches are implementing First Step Next (FSN) in two different classrooms. One of the coaches is part time and assists in a classroom during centers time in the morning, and the other is fulltime and acts as a floater to assist teachers and staff with behavior situations.

Riley Intermediate School

Mr. Cooper is providing weekly consultation to the school team. A STOIC plan has been developed for a classroom with several challenging students. It is being implemented and there have been improvements in student's behavior.

Sunnyside Intermediate School

A PAEC coach is assisting a teacher with improving class-wide behavior and implementing specific strategies with two challenging students. There have been improvements in the class and with the students. Another student in a different classroom has just recently been designated for behavior support. Steps are being taken to secure parent permission to begin working with the student.

Whittier Primary School

Observations and consultation by Mr. Cooper is being provided regularly for a student with escalating behaviors. A STOIC plan has been developed and new strategies are being implemented.

MacArthur Middle School

A 7th grade special education student is receiving twice a week mentoring sessions from a Behavior Coach. The student has been responding well. Another student, a sixth grader, has been suggested for a mentoring/goal-setting intervention as well.

District 88

Grant Primary School

We recently received parent permission to implement FSN with a student in an afternoon session. Mr. Cooper, filling in for a behavior coach who resigned, met with the mother and has begun preliminary class role-plays and individual role-plays.

Lincoln Primary School

Whole class FSN strategies are being taught by a Coach to the teacher and program assistant in a classroom with two very challenging students.

Lincoln Elementary School

A PAEC Behavior Coach has been implementing First Step with a student. Behavior has improved overall, but there are still issues outside the classroom. Consultation with the Principal and other staff to address the challenges in common areas are being implemented.

McKinley Elementary School

The Behavior Coach helping a teacher implement a First Step Next Maintenance plan for a student with physically aggressive behavior is still out on medical leave. When the teacher returns we hope to resume monitoring the maintenance plan.

District 209

Proviso East High School

The interventionists at East regularly attend seven different meetings on a weekly and biweekly basis. They are members of the MTSS team and the Care Team, as well as staff meetings, freshmen academy meetings, principal meeting, etc. They continue to focus on students identified as struggling with the competency-based academic structure as well as individuals with social-emotional issues that are assigned to them.

Proviso West High School

A PAEC interventionist at West continues to use 'Behavior report cards' with 8 IEP students that are seen on a daily basis. There have been some difficulties with teachers not fulfilling their monitoring responsibilities with this progress-monitoring tool, but we hope to remedy this. Both interventionists are active in collaborating with Deans to conduct conflict resolution sessions with students as well as peer mediation meetings, which occur on a daily basis. These strategies are reported to be effective with the majority of student meetings.

PAEC OT/PT Department

The AT Team continues to conduct SETT meetings. This past month meetings were held for students in the PAEC programs and one at Helping Hand in Countryside. Ongoing SETT process for trials and training with students in District 87.

We had our monthly OT/PT Departmental meeting on March 14, 2019.

We had 6 therapists participate in the District 87 Pre-School Screenings at Eisenhower Center on March 15, 2019.

On March 20th and 21st, we had two OTs attend the Conference for School-Based Occupational Therapists and OT Assistants in Alsip.

On March 21st, we had an OT attend Dyslexia, Dyscalculia & Dysgraphia by Mary B. Asper, MS, CCC-SLP in Naperville.

On March 21st in Skokie, we had two PTs attend and on March 22nd in Schaumburg, one PT attend, Essential Assessment & Treatment Strategies for Pediatric Orthopedic Dysfunction by Crystal Duda, MSPT.

On March 15th, we attended Navigating Cultural Differences within Student-Practitioner Relationships by Jordan Skowronski, MSOT, OTR/L at PAEC Center.

The AT Team attended the Infinitec West Coalition meeting on March 13, 2019 at CASE.

Our AT Team & OT/PT Team helped run the Wheelchair Clinic on March 13th at PAEC Center and the AT Team ran an Orthotic Clinic on March 20th, with Gwen Blunk, an orthotist from Hanger Clinic at PAEC Center.

The OT/PT/AT Lead attended the 35th International Seating Symposium with the theme of "Bridging the Gap from Data to Value" from March 20th through 22md, in Pittsburgh, PA.

PAEC Psychologist Department

PAEC/MMS Psychologist, Dr. Michael Cermak, attended the National Association of School Psychologists (NASP) conference in Atlanta, Georgia, from February 25th - March 1, 2019. He gave a presentation on the McKinney-Vento Act which addresses homelessness for students and families.

Lead Psychologist, Mary Therese Geary, is in the process of interviewing interns and practicum students for the 2019-20 school year.

On March 11th, PAEC Psychologists, Emily Adelson, Jennifer Orrico, Stephanie Rosas, and Treavon Burton, attended a workshop offered through STARNET, entitled "Families with LGBT Members". They will share information at the next Psychologists' meeting.

Ms. Geary met with Ms. Mary Beth Boeh on March 15th to plan for the psychologists' department budget for the 2019-20 school year.

On March 15th, Bilingual Psychologists, Paola Gonzalez-Bonet and Stephanie Rosas, assisted at the District 87 Pre-K community screening held at Eisenhower Community Center in Hillside.

MacArthur Middle School (MMS) Psychologist, Dr. Michael Cermak and Northlake Middle School/Riley Intermediate School Psychologist, Mrs. Emily Adelson, attended the District 87 MTSS committee meeting held on March 12, 2019.

MMS Psychologist, Dr. Michael Cermak, participated in the Erin's Law presentation for students on March 13, 2019. Dr. Cermak, along with the school counselor and social worker, followed up with students identified as needing further social-emotional support.

Several psychologists attended the March 15th in-service held at PAEC entitled, "Navigating Cultural Differences within Student-Practitioner Relationships". Information will be shared at the next Psychologists' meeting.

A psychologists' meeting was held on Friday, March 22, 2019. Topics included workshops attended by psychologists over the last month, including PAEC and off-campus professional development.

Northlake Middle School Psychologists, Emily Adelson and Jennifer Orrico, participated in the Erin's Law presentation for students on March 18, 2019. The Psychologists, along with the school counselor and social worker, followed up with students identified as needing further social-emotional support.

PAEC Social Work Department

Ms. Lisa Pirrello, LCSW (PAEC Lead School Social Worker), Ms. Donna Kuchera, MSW (PAEC School Social Worker - Proviso West High School) and Mr. Michael Irgang, MSW (PAEC School Social Worker - PAEC Elementary), will be assisting with registration at the Annual School Safety Conference, that is to be held on April 17, 2019 at Monty's Elegant Banquets in Bensenville, IL 60106.

The PAEC School Social Work Department is now accepting applications for potential School Social Work Interns for the 2019-20 school year and may now complete the PAEC online application.

Ms. Donna Kuchera, MSW (PAEC School Social Worker-Proviso West High School), as an active member of the Proviso West High School PBIS Team, is currently involved in the planning, coordination and facilitation of the school's first incentive/reward of a Movie in the Little Theatre for any student recognized for exemplary behavior. Additionally, Ms. Kuchera has been working with students who have been identified as having Autism Spectrum Disorder in social work group and introducing skills/topics that would benefit the TST population, as well as working on Senior Template Letters to place in the senior's IEP.

Mr. Saumil Patel, MSW, and Ms. Jill Collins, MSW (PAEC School Social Workers-PAEC Center), are currently involved in the following:

- Active Graduation Committee Members
- Active Special Events Committee Members
- Assisted in Facilitating the "World Down Syndrome Day" at PAEC Center
- Mr. Patel is currently the Special Olympics Basketball coach and had the role of Chaperone for the Special Olympics Illinois State Basketball Finals Tournament.

Ms. Lindsey Holsten, LCSW, and Mr. Michael Irgang, MSW (PAEC School Social Workers-PAEC Elementary School), have been overseeing the PAEC Elementary Recycling Program. Each Friday, whereby they collect all recyclables throughout the week and choose two students from the school to assist with the sorting of items, removing all paper and cardboard products and bringing them to the Garfield Elementary parking lot to recycle in the bin which donates part of the proceeds to the community. Ms. Holsten and Mr. Irgang are also currently involved in running a weekly girls group with an outside therapist, which focuses on self-regulation, coping skills and self-esteem. Additionally, they will be introducing the Sunshine Circles curriculum to the 4-6th grade classrooms after spring break.
