This agreement provides the necessary space we require for our classes at a cost of \$85,000.00 from July 1, 2019 through June 30, 2020, \$87,550.00 from July 1, 2020 through June 30, 2021, \$90,176.50 from July 1, 2021 through June 30, 2022, \$92,881.80 from July 1, 2022 through June 30, 2023, and \$95,663.25 from July 1, 2023 through June 30, 2024. I am recommending that we approve this lease agreement.

Ms. Johnson pointed out an error on the lease agreement, item 18-B3, Ms. Boeh explained that our attorney is aware of the error and he is working to correct the error.

Ms. Boeh explained that Divine Infant is a newer building, move-in ready, classrooms are bigger, there is air condition and PAEC Academy will be on the lower level.
