Device Management

All equipment related to technology are to be returned in the same condition as sent. (i.e., chromebooks, chargers, bags, headphones). Lost or damaged chromebooks will disrupt standard classroom routines when they return. Damaged and/or lost devices will be fined on a case by case basis.

Alternative to Technology

For whatever reason that the student is not able to gain access from home, work sent home by paper must be returned to receive credit and to be marked as present.

Instructional Materials

Standard work packets were sent home as an alternative. If you request that your student have more challenging material please contact Ms. Kural, Interventionist.

Attendance and Participation:

- Students must log in and attend their classes online during their regularly scheduled class periods.
- Attendance will be taken during the assigned class time.
- For students who do not attend online (grades K-3), work packets have been sent home and must be returned in order to receive credit and attendance.
- Students are expected to participate appropriately, following all school rules and technology guidelines.

Coursework Expectations:

- All assignments, lessons, and activities will be provided through the school's designated online learning platform.
- Students are expected to complete all assigned work during the remote learning period.
- Work assigned during remote learning must be turned in upon the student's return to school, unless directed otherwise by the teacher.
- Failure to complete or submit assignments may result in academic consequences consistent with school policy.

Communication:

- Students must regularly check their school email and online classroom for updates and instructions.
- Students are responsible for contacting their teachers if they experience technical issues or have questions regarding assignments.
- Parents/guardians are encouraged to support student accountability during remote learning days.

Behavior Expectations:

- Students must follow the school's Code of Conduct while participating in remote learning.
- Appropriate language, attire, and behavior are required during all virtual classes.
- Any misuse of technology or disruptive behavior may result in disciplinary action.

Return to School:

- Send all materials back.
- Upon returning to in-person instruction, students must submit all completed remote learning assignments.
- Teachers may review or assess work complete during the remote learning period to ensure mastery of content.
